PROCLAMATION

RE: SHELLFISH POLLUTED AREA

Stephen W. Murphey, Director, Division of Marine Fisheries, upon the recommendation of Betsey Tilson, M.D., M.P.H., State Health Director, Department of Health and Human Services, hereby announces that the following change in a shellfish harvesting area will take effect at sunrise, Thursday, December 19, 2019.

All those waters in Onslow County will return to the status in existence immediately prior to the December 14, 2019, temporary closure.

The following remains closed:

BRUNSWICK / NEW HANOVER / CARTERET COUNTIES

All those waters between the permanent closure line near IWW Marker "89" in Ocean Isle, and the South Carolina State Line, to include the Tubbs Inlet area.

All those waters bordered on the east by a line beginning at a point 33° 54.2904' N - 78° 23.6416' W on the mainland near the Bricklanding Road Public Boat Ramp and IWW Beacon "84"; running southerly to a point 33° 54.1932' N - 78° 23.6426' W on Ocean Isle Beach near Ferry Landing Park; and bordered on the west by the permanent closure line near IWW Marker "89" in Ocean Isle.

Lockwoods Folly River - All those waters north of a line beginning at a point 33° 55.5678' N - 78° 13.8043' W on the south shore of Spring Creek near the mouth; running easterly to a point 33° 55.4621' N - 78° 13.1714' W near the northern tip of Sheep Island; thence running southeasterly to a point 33° 55.2284' N - 78° 12.7791' W near the northwest point of Horse Island, to include a portion of the Intracoastal Waterway north of Horse and Sheep Islands.

All those waters in Little Creek, near the Figure Eight Island Bridge, upstream of a line across the mouth beginning at a point 34° 16.5626' N - 77° 45.6284' W, running northeasterly following the marsh to a point 34° 16.7452' N - 77° 45.4634' W.

Newport River - All those waters in Newport River upstream of a line beginning at a point 34° 45.6960' N - 76° 43.5180' W on the south shore near Penn Point; running northeasterly to a point 34° 46.5733' N - 76° 42.6350' W on the north shore near the Hardesty Farms subdivision (near the Newport River DMF Shrimp Line).

GENERAL INFORMATION:

- A. This proclamation is issued under the authority of N.C.G.S. 113-170.4; 113-170.5; 113-182; 113-221.1; 143B-289.52 and N.C. Marine Fisheries Commission Rules 15A NCAC 03H .0103 and 03K .0101.

- B. It is unlawful to violate the provisions of any proclamation issued by the N.C. Fisheries Director under his delegated authority pursuant to N.C. Marine Fisheries Commission Rule 15A NCAC 03H .0103.
- C. In accordance with N.C. General Statute 113-221.1(c) all persons who may be affected by proclamations issued by the Fisheries Director are under a duty to keep themselves informed of current proclamations.
- D. This proclamation returns the following area to normal closure boundaries: Queens Creek.
- E. This reopening is due to satisfactory bacteriological sampling results.
