NOAA Fisheries Service Seeks Public Comment on a Draft Supplemental Environmental Impact Statement for Spiny Lobster in the Gulf of Mexico and South Atlantic *Comment Period Ends March 19, 2012*

NOAA Fisheries Service is seeking public comment on a draft environmental impact statement for Amendment 11 to the Fishery Management Plan for Spiny Lobster in the Gulf of Mexico and South Atlantic. The Environmental Protection Agency announced the availability of the draft environmental impact statement on February 3, 2012.

The Gulf of Mexico and South Atlantic Fishery Management Councils (Councils) are currently considering regulatory action needed to address actions to protect threatened and endangered species, including closing areas to protect elkhorn and staghorn corals and requiring trap lines to have markings unique to the fishery. These actions were originally included in Amendment 10 to the fishery management plan; however, the Councils chose to take no action at that time to allow for additional stakeholder input. The draft environmental impact statement analyzes the environmental impacts of these proposed actions.

Request for Comments

Written comments on this draft environmental impact statement must be received no later than **March 19, 2012**, in order to be considered by NOAA Fisheries Service. See the **Addresses** section for information on where and how to submit comments.
